Mrs. Debbie Mitchell, local RULHEA President was present to share information from the Calendar Committees meeting to review the recently submitted drafts of the School Calendar for the 17-18 School

Mrs. Mitchell stated that the teachers and the committee were very pleased with the draft calendars as submitted. However, she said that speaking on behalf of the teachers, they would like to request the inclusion of two (2) early dismissal days be added to the calendars on the day before Christmas, and the la day of school. Both days having a dismissal time of 1:00 pm. She stated that the teachers understand the reduced funding the District is encountering, and not anticipated the size of raise they feel is warranted. Therefore, they are asking for these early dismissal days be considered as alternative consideration of appreciation.

Dr. Naylor voiced her concern over the fact that these early dismissal days basically add up to a full nonteaching day. She also noted that since we have more inservice days in the calendar than required, we could reduce the number of in-service days, and replace with an instructional day.

Mrs. Huff, Mr. Sims, and Mr. Wilson all voiced their interest in allowing these early dismissal days.

Mr. Wilson asked Dr. Naylor if a decision needed to be made tonight.

Dr. Naylor stated that the goal is to have 2 calendars voted on by OEA and presented to Board by March regular meeting. She stated that she would rework the proposed calendars to include the early dismissals, and review those with the calendar committee.
