



RULH School Hall of Fame Criteria

1. The nominee must be a graduate of RULH, Aberdeen or Higginsport high school.
2. The nominee must have competed in athletics at one of the above mentioned high schools and must be 5 years removed from high school graduation.
3. Any athlete that meets at least 5 of the following criteria is eligible for a nomination.
 - A. The nominee must have been selected to one or more of the following:
 - a. All Brown County, All-Southern Hills League, or All-SHAC
 - b. All-district
 - c. All-region
 - d. All-state
 - e. All-American
 - B. Nominee must be a league champion, sectional champion, district champion, regional champion or State champion as a member of a team. If an athlete qualified at any of these levels as an individual, they too are eligible for nomination..
 - C. Nominee must hold an individual or multiple records in a specific or multiple sports.
 - D. Former athletes nominated in basketball must qualify with one or more of the following:
 - a. 1000 point club
 - b. 400 plus points in a single season
 - c. 350 plus rebounds for a career
 - d. 250 plus assist for a career
 - e. 200 plus steals for a career
 - E. Former athletes nominated in baseball and softball must qualify with one or more of the following:
 - a. Athlete must have held over a .350 career batting average.
 - b. Athlete must have a single season batting average over .400.
 - c. Fielding percentage over .800
 - d. Athlete must have had over 150 career strikeouts as a pitcher.
 - e. Must be school record holder in at least one baseball statistical category.
 - F. Former athletes nominated in soccer must have the following:
 - a. 18 plus goals in a single season
 - b. Be in the top 5 all time in school history in saves
 - c. Be a record holder in some statistical category for a period lasting 3 years or longer
 - d. Often times in soccer there are no charted defensive statistics to document such nominations. Therefore, in case where an athlete was a defensive player, the athlete must be nominated by a school administrator, former coach, former teammate or someone who is already a member of the RULH Hall of Fame.

- G. Former athletes nominated in volleyball must hold an individual record, in at least one statistical category.
 - a. Must have set school record for highest percentage serve.
 - b. Must have held record for most points scored
 - c. Must have record for most assists
 - d. Must have record for most digs
 - e. Often times in volleyball there are no charted defensive statistics to document such nominations. Therefore, In the case an athlete was a defensive player, the athlete must be nominated by a school administrator, former coach, former teammate or someone who is already a member of the RULH Hall of Fame.
- H. Former athletes nominated in cross country and track must have one or more of the following:
 - a. Set a school record in a specific event and hold that record for at least 3 years
 - b. Been a member of a team that qualified for a regional or state birth
 - c. Had an overall average of under 17:30 (men) or under 20:00 (women) minutes for a career
 - d. Qualified for regional or state competition as an individual
- I. Any former athlete that won a varsity award letter while at RULH, that played at least one collegiate season is eligible for a nomination.
- J. Former coaches nominated must meet at least 3 of the following:
 - a. Must be a past or present coach at RULH High School or Middle School
 - b. Must have coached minimum 5 years at RULH
 - c. He or she must have been a coach on a sectional, district or regional championship team
 - d. Must have won at least 3 league championships as a head coach during their respective tenure at RULH
- K. Must have been a volunteer member of RULH support staff for a minimum 10 years in some capacity.
- L. If any former student-athlete has been selected to all-conference, all-district, all-city, or all-state in 2 or more sports they are also eligible for a nomination.
- M. Must have been selected as a Southwest district 16 player of the year finalist. Have been nominated and participated in the Southwest East vs. West all-star game in their respective sport or sports.

Please keep in mind that a nomination does not automatically guarantee the nominee's place into the RULH Hall of Fame.
